Fee Payment terms and conditions

1. All fees due are to be settled in full before a child can start attending the nursery.
2. The one-time Registration fee is non-refundable, non transferable and payable in full at the time of enrollment.
3. Tuition fee for the whole term is payable in advance at the start of each term, in order to secure the child's place in the nursery. Tuition fees paid prior to the beginning of any academic Term are refundable and only the registration / re-registration fees will be deducted. This will be followed, provided a written advance notice is given 15 days prior to the start of the new term.

If written notice is given after the term has started, regardless of whether attendance started or not, there will be some deduction of tuition fee. This will look as follows:

- a. two weeks or less have passed since start of term: a month's fees will be deducted.
 - b. two weeks to one month have passed since start of term: two months' fees will be deducted.
 - c. More than a month has passed since term started: full term fee will be deducted.
4. Change of child's attendance can only be admitted if full fee for new days and timings of attendance are cleared in advance.
 5. In the event of non-payment of tuition fee by due date, the nursery, at its exclusive discretion reserves the right to either: a) levy a **late payment penalty @ AED 100 per day of delay**, or b) refuse child's attendance at the nursery and withhold all nursery reports including KHDA transfer certificate.
 6. For children continuing at the nursery after June of any year, the nursery may ask for a retainer fee in term 3, which would be adjusted against the fee for the next term starting in September.
 7. All fee are subject to change, however, the nursery will provide adequate prior notice of the same to parents.
 8. Camp attendance during term breaks and/or summer holidays are charged separately. This fee needs to be paid in advance and once paid is non-refundable and non-transferable.
 9. Care for additional days or hours, other than those specified at enrollment may be availed, subject to availability, and the nursery would charge for these separately. Advance notice **in writing** is required for such care by the nursery.
 10. The nursery holds the right to charge late fee in case you are late collecting your child on any day at the rate specified in the fee schedule.
 11. In line with UAE Labour Law and with traditional practices, public holidays and shortened work day in Ramadan will be observed by the nursery and full fee applies for all these periods without any adjustments/reductions.
 12. Educational field trips and extra-curricular activities may be organized from time to time and the nursery may charge additional fee to those who choose to attend these. Such Fees are payable separately and are not included in tuition or any other fee.
